The reserve account is \$525k. Bob Giese made a motion that \$200k be moved to a 6-month CD second by Guy Miata motion carried unanimously. (4-0)

The balance of the roof loan is \$131,287.01 as of June8, 202. This loan will be paid in full by January 1, 2024.

The board will discuss the Road Project options and look for help from owners with financial background to assist in the analysis of financing it. The special assessment payments have been coming in and we will have a better understanding of delinquents with the June financial statement.

Motion to accept the treasure's report was accepted by Lorrie Beaumont seconded by, Garry Dunn. Motion carried unanimously. All in favor. (4-0)

VIII. New Business:

- a. POD discussion should discuss changing rules. More people are moving with POD's and if it can fit in the driveway without hanging out should consider.
